### Pension Board Nomination Process & Election

Released May 12, 2025

There will be one board trustee position open on September 01, 2025<sup>1</sup>. This is as a result of the incumbent, Troy Marchese retiring from service.

Active Sworn Members<sup>2</sup> wishing to participate in this election should announce their candidacy to the Board of Trustees “in written form”, no later than June 12, 2025 by 9:00 AM.

If an election is warranted, the election dates will be June 19, 2025 thru July 10, 2025 by 9:00 AM. If a runoff election is warranted, the election dates will be July 17, 2025 thru August 07, 2025 by 9:00 AM.

Ballots will be mailed to the address on file with the Office of Retirement. Detailed voting instructions will be included as well. This matter is time sensitive, as such the properly executed ballots must be received by the date(s) & time(s) cited, or they will not be counted.

Ballots will be opened and tallied directly after the election in the Palm Beach PBA Conference Room. The counting process is open to any member. The candidate receiving the most votes win.
